1. Purpose of this CoP-COSP: To be the hands for each other, be supportive to families and provide fidelity in COSP practices for B-3 Programs.

2. DCF Grant for COSP Facilitators Update: There is a hold on DCF funding of Facilitator training until July.

3. COSP participants completion:

* COSP B-3 facilitators: Estimate of 35-40 Facilitators across the State in 12 B-3 Programs.(20-24 Trained through this project & DCF Grant)

* 140 Service providers completed the 8 week COSP experience in 15 B-3 Programs

* 15 B-3 Facilitators completed the COSP Refresher Course.

4. IFSP Documentation:

Individualized Family Outcome-When writing a Family Outcome to support facilitating COSP with a family; think about each family's individual need and how COSP will support them, (ex: Family would like to learn more about helping their child regulate their challenging behaviors.)

- In regard to Documentation of Services on Section 7 (service grid); it is important to document the discipline of the COSP facilitator (e.g., PT, OT, DT, etc.) and NOT document it as "COSP Facilitator".
- Follow the CT Birth23 Procedure "Planning and Documentation of Intervention Services" for further guidance.
- Remote Deliver- PA for remote only(Follow remote procedure)
